**ORDER ADOPTING SERVICE LIST AND

Pursuant to the Federal Register Notice (FRN) issued on May 29, 2009, Bonneville Power Administration (BPA) is reopening the Power Tiered Rate Methodology Rate Case (TRM) proceeding under section 7 of the Northwest Power Act to consider proposed changes to the TRM.
